This information pertains to one of the Group and Region-Focused Training of the Japan International Cooperation Agency (JICA), which shall be implemented as part of the Official Development Assistance of the Government of Japan based on bilateral agreement between both the Governments or recipient country and Japan.

I. Concept

Background

The United Nations designated the year 2002 as "the International Year of Ecotourism" to encourage more people to see tourism from the viewpoint of sustainable development. Ecotourism aims to help people experience and understand local natural environments and traditional culture, contributing to better conservation of these assets as well as community development.

The World Tourism Organization (WTO) defines sustainable tourism as tourism that conserves not only natural resources but also historical heritage and tangible/intangible resources including tradition and culture, as well as tourism in which visitors cherish precious sightseeing resources and contribute to their passage to the next generation. In many developing countries, tourism is an important industry that brings foreign currency, and is valued in terms of regional development advantages such as the creation of job opportunities in the relevant areas and regional economic revitalization. Equal emphasis on the development and conservation of tourism resources is a vital issue. At the same time, environmental conservation is a highly important and urgent issue in economic and social development.

For what?

This program aims to realize the introduction and promotion of eco-tourism, which goes a log way toward environmental conservation, wise use of natural resources and contribution to community, based on the above-mentioned international environmental laws.

For whom?

National/local government organizations and NGOs involved in tourism promotion or efforts to conserve the natural environment and cultural resources

How?

Participants shall have opportunity in Japan to:

1) visit national parks, Ramsar sites and historical places,

2) practice some field activities such as hiking, canoeing and horseback riding, and

3) have discussions with the program leader or lectures to achieve program objective.

2. Course Period in JAPAN:

July 21st to September 1st, 2015

3. Target Countries:

Costa Rica, El Salvador, Belize, Seychelles, Guyana, Peru, Suriname, Albania, Serbia, Former Yugoslav Republic of Macedonia

4. Eligible / Target Organizations: National/local government organizations and NGOs involved in tourism promotion or efforts to conserve the natural environment and cultural resources

5. Course Capacity (Upper limit of Participants): 10 participants

6. Language to be used in this program: English

7. Course Objective:

Draft plans to introduce and disseminate ecotourism as a tool for sustainable regional development involving local residents for areas, where the introduction of ecotourism is expected, are formulated by the target organizations.

8. Overall Goal:

The plan to establish an organization and a network that include local residents will be drafted for the introduction and operation of ecotourism, and the plan to disseminate ecotourism for both tour providers and users will be implemented.

9. Expected Module Output and Contents:

This program consists of the following components:

III. Conditions and Procedures for Application

1. Expectations for the Participating Organizations:

- (1) This program is designed primarily for organizations that intend to address specific issues or problems identified in their operation. Participating organizations are expected to utilize the program for those specific purposes.
- (2) This program is enriched with contents and facilitation schemes specially developed in collaboration with relevant prominent organizations in Japan. These special features enable the program to meet specific requirements of applying organizations and effectively facilitate them toward solutions for the issues and problems.
- (3) As this program is designed to facilitate organizations to come up with concrete solutions for their issues, participating organizations are expected to make due preparation before dispatching their participants to Japan by carrying out the activities of the Preliminary Phase described in section II -9.
- (4) Participating organizations are also expected to make the best use of the results achieved by their participants in Japan by carrying out the activities of the Finalization Phase described in section II -9.

2. Nominee Qualifications:

Applying organizations are expected to select nominees who meet the following qualifications:

- <u>Current duties</u>: Planning or promotion of Eco-Tourism for conservation of natural environment and cultural resources. e.g. Middle-ranking administrative officers, etc.
- (2) Experience in the relevant fields: More than two (2) years
- (3) Be nominated by their governments
- (4) <u>Language</u>: competent command of spoken and written English, which is equal to TOEFL iBT* 72 (CBT** 200/PBT*** 533) or more (The program is commanded by English, therefore participants are requested to have sufficient English ability),

*iBT: Internet-Based Testing/ **CBT: Computer-Based Testing/ ***PBT: Paper-Based Testing,

- (5) <u>Health</u>: must be in good health, both physically and mentally, to participate in the Program in Japan
- (6) Must not be serving any form of military service.

4. Procedure for Application and Selection:

(1) Submitting the Application Documents:

Closing date for application to the JICA Hokkaido International Center (Obihiro), Japan: June 5, 2015

Note: Please confirm the closing date set by the respective country's JICA Office or Embassy of Japan of your country to meet the final date in Japan.

(2) Selection:

After receiving the document(s) through due administrative procedures in the respective government, the respective country's JICA Office (or Japanese Embassy) shall conduct screenings, and send the documents to the JICA Center in charge in Japan, which organizes this program. Selection shall be made by the JICA Center in consultation with the organizations concerned in Japan based on submitted documents according to qualifications.

(3) Notice of Acceptance:

Notification of results shall be made by the respective country's JICA Office (or Embassy of Japan) to the respective Governments by **not later than <u>June 19</u>**, <u>2015</u>.

5. Conditions for Attendance:

- (1) to strictly adhere to the program schedule.
- (2) not to change the program topics.
- (3) not to extend the period of stay in Japan.
- (4) not to be accompanied by family members during the program.
- (5) to return to home countries at the end of the program in accordance with the travel schedule designated by JICA.
- (6) to refrain from engaging in any political activities, or any form of employment for profit or gain.
- (7) to observe Japanese laws and ordinances. If there is any violation of said laws and ordinances, participants may be required to return part or all of the training expenditure depending on the severity of said violation.
- (8) to observe the rules and regulations of the accommodation and not to change the accommodation designated by JICA.



For Your Reference

JICA and Capacity Development

The key concept underpinning JICA operations since its establishment in 1974 has been the conviction that "capacity development" is central to the socioeconomic development of any country, regardless of the specific operational scheme one may be undertaking, i.e. expert assignments, development projects, development study projects, training programs, JOCV programs, etc.

Within this wide range of programs, Training and Dialogue Programs have long occupied an important place in JICA operations. Conducted in Japan, they provide partner countries with opportunities to acquire practical knowledge accumulated in Japanese society. Participants dispatched by partner countries might find useful knowledge and re-create their own knowledge for enhancement of their own capacity or that of the organization and society to which they belong.

About 460 pre-organized programs cover a wide range of professional fields, ranging from education, health, infrastructure, energy, trade and finance, to agriculture, rural development, gender mainstreaming, and environmental protection. A variety of programs and are being customized to address the specific needs of different target organizations, such as policy-making organizations, service provision organizations, as well as research and academic institutions. Some programs are organized to target a certain group of countries with similar developmental challenges.

Japanese Development Experience

Japan was the first non-Western country to successfully modernize its society and industrialize its economy. At the core of this process, which started more than 140 years ago, was the "adopt and adapt" concept by which a wide range of appropriate skills and knowledge have been imported from developed countries; these skills and knowledge have been adapted and/or improved using local skills, knowledge and initiatives. They finally became internalized in Japanese society to suit its local needs and conditions.

From engineering technology to production management methods, most of the know-how that has enabled Japan to become what it is today has emanated from this "*adoption and adaptation*" process, which, of program, has been accompanied by countless failures and errors behind the success stories. We presume that such experiences, both successful and unsuccessful, will be useful to our partners who are trying to address the challenges currently faced by developing countries.

However, it is rather challenging to share with our partners this whole body of Japan's developmental experience. This difficulty has to do, in part, with the challenge of explaining a body of "tacit knowledge," a type of knowledge that cannot fully be expressed in words or numbers. Adding to this difficulty are the social and cultural systems of Japan that vastly differ from those of other Western industrialized countries, and hence still remain unfamiliar to many partner countries. Simply stated, coming to Japan might be one way of overcoming such a cultural gap.

JICA, therefore, would like to invite as many leaders of partner countries as possible to come and visit us, to mingle with the Japanese people, and witness the advantages as well as the disadvantages of Japanese systems, so that integration of their findings might help them reach their developmental objectives.
