Singapore Cooperation Programme

Singapore has provided technical assistance to other developing countries since the 1960s. As a country whose only resource is its people, Singapore believes that human resource development is vital for economic and social progress. Singapore itself has benefited from training provided by other countries and international organisations.

In 1992, the Singapore Cooperation Programme (SCP) was established to bring together under one framework the various technical assistance programmes offered by Singapore. Through the SCP, the range and number of training programmes were increased to share Singapore's development experience with other developing countries. To date, Singapore has sponsored training courses and study visits for over 90,000 officials from more than 170 countries. The SCP is managed by the Technical Cooperation Directorate of the Singapore Ministry of Foreign Affairs.

Course Objectives

This course should provide participants a broad overview of the various commercial aspects in relation to ship economics, operations and management. The wide range of topics covered will equip the participants with the necessary knowledge to understand the roles of players in the maritime industry and to appreciate the several dimensions to ship owning, management and operation.

Synopsis and Methodology

On successful completion, the participants shall be able to:

- Develop an understanding of Maritime economics and the Demand for shipping.
- Explain the key functions in ship ownership, management and the responsibilities in each area, the different types of organisation structure, laws pertaining to ship management and essential components of a ship management contract.
- Identify the characteristics of major world cargoes and their importance in shipping markets; discuss the importance of properly stowing cargoes and the safe handling of dangerous cargo according to International Maritime Dangerous Goods (IMDG) Code as well as recognize the importance of cargo outturn and the role of damage survey in settling damage claims.
- Explain the procedures and things to take into account when registering a ship, describe the role and importance of classification as well as discuss the international conventions and regulations that are in place to ensure the safety and security of those working in the maritime industry.
- Explain the various aspects of Shipping Costs
- Have an understanding of the Ship Operations and appreciate the importance of Voyage Estimation and its relevant factors
- Discuss the importance of crew management as a part of operating cost and the essential elements of crew costs as well as state the international standards that are in force for crew.
- Describe the different types of insurance and the various concepts that are used in marine insurance as well as state the proper procedure to handle cargo claims, repudiations, surveys and contractual exceptions.

The Commercial Aspects of Shipping Economics, Operations and Management cover the following topics:

- Introduction to Maritime Economics, Economic Analysis of the Demand for Shipping
- · Ship owners, Operators and Managers
- Rules and Regulations relating to Ship Management - Legal relationship between ship owner, operators and manager and cargo interests / third parties
- Introduction to Shipping services, Ship Types and Cargoes (Cargo Management)
- Registration, Classification, International Conventions and regulations relating to maritime safety and maritime security; Port State Control
- Shipping Costs Basic concepts, Vessel Operating Costs and other Cost Factors
- Fleet management and operation -Importance of Voyage Estimation - Ship Owner's Perspective
- Crew Management, essential elements of crew costs and International standards relating to the crew
- Bunker Management, Fuel Efficiency
- Marine Insurance Market introduction to various concepts and procedures to handle claims

An action-oriented, highly participative approach will be employed throughout the training. Training methods will combine lectures, group discussions, case studies.

Duration

The course will be held from 11 to 14 August 2015.

Application Information

Applicants should be:

- For government officials, managers and operators with experience in ship management
- · Nominated by their respective Governments
- · Proficient in spoken and written English
- In good health

Terms of Award

The course is sponsored by the Government of Singapore under the Singapore Cooperation Programme Training Award and the Small Island Developing States Technical Cooperation Programme.

Under this programme arrangement, the Government of Singapore will bear the following expenses for the successful applicants (thereafter known as participants) during their training in Singapore. These expenses include:

- A daily training allowance of One Hundred and Twenty Singapore Dollars (S\$120) from first day to last day of the course to cover meals and daily expenses. [Complimentary breakfast is provided in the hotel from the first day to one day after the course.];
- Transportation to course venue and site visits;
- Medical insurance for participants to cover accident and hospitalisation during their stay in Singapore in accordance with the policy of a local insurance company; and
- Accommodation for the entire duration of the course.

Note:

- The nominating government will be responsible for their participants' round-trip airfares
- (ii) Participants are to bear their personal miscellaneous expenses that might be incurred prior to receiving the allowance
- (iii) Any expenses for out-patient medical/dental treatment will be borne by the participants themselves

Regulations

Participants are required to comply with the following:

- (a) Strictly observe course schedules and not miss training sessions;
- (b) Not bring any member of their family and/or aide for the duration of the course;
- (c) Carry out instructions and abide by conditions as may be stipulated by the nominating Government or the Government of Singapore with respect to the course;
- (d) Refrain from engaging in political activities, or any form of employment for profit or gain while in Singapore;
- (e) Discontinue the course, in the event they fall seriously ill and are considered unable to

- continue the training or have committed an improper act; and
- (f) Return to their respective home countries upon completion of the course.

Application Procedure

(Closing date for nomination: 29 June 2015)

The Government of Singapore is pleased to invite the respective National Focal Points for Technical Assistance to nominate <u>one (1)</u> suitable applicant.

Selection of candidates will be based on merit. Should there be more applicants than training places, the Government of Singapore seeks the understanding of the respective National Focal Points for Technical Assistance in the event that its nominee(s) is not selected.

All nominations are to be submitted by the respective Government Institutions, using the official application form. The application forms are to be submitted and should reach the Ministry of Foreign Affairs, Singapore through the National Focal Point and the Singapore Embassy in the nominating country not later than Monday, 29 June 2015.
