#### **Singapore Cooperation Programme**

Singapore has provided technical assistance to other developing countries since the 1960s. As a country whose only resource is its people, Singapore believes that human resource development is vital for economic and social progress. Singapore itself has benefited from training provided by other countries and international organisations.

In 1992, the Singapore Cooperation Programme (SCP) was established to bring together under one framework the various technical assistance programmes offered by Singapore. Through the SCP, the range and number of training programmes were increased to share Singapore's development experience with other developing countries. To date, Singapore has sponsored training courses and study visits for over 100,000 officials from more than 170 countries. The SCP is managed by the Technical Cooperation Directorate of the Singapore Ministry of Foreign Affairs.

# Singapore Environment Institute, National Environment Agency

Singapore Environment Institute (SEI) is the training and knowledge division in the National Environment Agency (NEA). The Institute helps to promote Singapore as an environmental hub by providing thought leadership in environmental sustainability and management for high-density, compact cities, the Institute also aims to spark off the development of innovative environmental solutions. This is done by connecting the public sector and private industries with renowned thought leaders, leading practitioners and experts, via strategic knowledge activities that foster communities of best practices. Its work also includes developing and managing a variety of learning programmes to enhance the competency environmental professionals and Singapore's environmental expertise. outcomes include NEA's inaugural technical magazine ENVISION, an aggregation of case studies and documentation, interview pieces and more. The collective body of knowledge will go on to instruct future generations of NEA officers.

SEI's key training areas cover:

- Climate Change and Energy
- Pollution Management
- Environmental Public Health Management
- Urban Environmental Management
- · Weather and Meteorological Services

#### **Course Objectives**

This course aims to provide participants with an overview of the tools and conceptual frameworks of urban solid waste management. Participants will also learn about the legislation and enforcement policies for the management of waste product in Singapore.

#### Synopsis and Methodology

The topics to be covered over the 5 -day programme would include the following:

- Environmental protection and management in Singapore
- Integrated solid waste management system (collection and disposal)
- · Waste minimisation and recycling in Singapore
- Control and management of hazardous substances and toxic wastes
- Legislation and enforcement policies of National Environment Agency (NEA)
- Public cleansing and environment sanitation

The programme would comprise the delivery of a systematic curriculum and relevant course materials that would be used for interactive discussions in the classroom. To achieve the above course objectives more effectively, these course materials will be delivered by a team of experts from relevant public agencies and industry in Singapore.

To enhance the output of the program and to crystallize the knowledge gained by participants, there will be discussion with the officials and policy makers on how they can incorporate the knowledge gained into their approaches in urban solid waste management in their country.

#### Duration

The course will be held from 22 to 26 February 2016.

#### **Application Information**

Applicants should be:

- Mid to senior level government officials with at least 2 years of working experience in policymaking for sustainability and environmental excellence or related fields.
- Nominated by their respective Governments
- Proficient in spoken and written English
- · In good health

#### **Terms of Award**

The course is sponsored by the Government of Singapore under the Singapore Cooperation Programme Training Award and the Small Island Developing States Technical Cooperation Programme.

Under this programme arrangement, the Government of Singapore will bear the following expenses for the successful applicants (thereafter known as participants) during their training in Singapore. These expenses include:

- A daily training allowance of One Hundred and Twenty Singapore Dollars (S\$120) from first day to last day of the course to cover meals and daily expenses. [Complimentary breakfast is provided in the hotel from the first day to one day after the course.];
- Transportation to course venue and site visits;
- Medical insurance for participants to cover accident and hospitalisation during their stay in Singapore in accordance with the policy of a local insurance company; and
- Accommodation for the entire duration of the course.

#### Note:

- (i) The nominating government will be responsible for their participants' round-trip airfares
- (ii) Participants are to bear their personal miscellaneous expenses that might be incurred prior to receiving the allowance
- (iii) Any expenses for out-patient medical/dental treatment will be borne by the participants themselves

### Regulations

Participants are required to comply with the following:

- (a) Strictly observe course schedules and not miss training sessions;
- (b) Not bring any member of their family and/or aide for the duration of the course;
- (c) Carry out instructions and abide by conditions as may be stipulated by the nominating Government or the Government of Singapore with respect to the course;
- (d) Refrain from engaging in political activities, or any form of employment for profit or gain while in Singapore;
- (e) Discontinue the course, in the event they fall seriously ill and are considered unable to continue the training or have committed an improper act; and
- (f) Return to their respective home countries upon completion of the course.

#### Application Procedure

(Closing date for nomination: 11 January 2016)

The Government of Singapore is pleased to invite the respective National Focal Points for Technical Assistance to nominate one (1) suitable applicant.

Selection of candidates will be based on merit. Should there be more applicants than training places, the Government of Singapore seeks the understanding of the respective National Focal Points for Technical Assistance in the event that its nominee(s) is not selected.

All nominations are to be submitted by the respective Government Institutions, using the official application form. The application forms are to be submitted and should reach the **Ministry of Foreign Affairs**, **Singapore** through the National Focal Point and the Singapore Embassy in the nominating country not later than **Monday**, 11 January 2016.
