The department directors of Ministry of Environmental Protection, senior professors and the reputable experts will be invited for the lecture. In addition, we will make field trips to visit waste water treatment plant, waste incineration plant, landfills, demonstration cases of ecological and environmental protection, outstanding cases concerning the improvement of urban environment as well as enterprises of circular economy and clean production. During the spare time, visits to see Chinese culture will be arranged, too.
