This information pertains to one of the JICA Knowledge Co-Creation Program (Group & Region Focus) of the Japan International Cooperation Agency (JICA), which shall be implemented as part of the Official Development Assistance of the Government of Japan based on bilateral agreement between both Governments.

#### 'JICA Knowledge Co-Creation Program (KCCP)' as a New Start

In the Development Cooperation Charter which was released from the Japanese Cabinet on February 2015, it is clearly pointed out that "In its development cooperation, Japan has maintained the spirit of jointly creating things that suit partner countries while respecting ownership, intentions and intrinsic characteristics of the country concerned based on a field-oriented approach through dialogue and collaboration. It has also maintained the approach of building reciprocal relationships with developing countries in which both sides learn from each other and grow and develop together." We believe that this 'Knowledge Co-Creation Program' will serve as a center of mutual learning process.

## I. Concept

#### **Background**

Recently, the role of forests in terms of climate change has been highlighted worldwide. The forestry sector including deforestation accounts for 17.4 percent of total CO2 emissions, which is more than the share of total emissions from the transport sector. Based on the FAO statistics, there was a 129 million hectares forest net loss between 1990 and 2015, and to tackle this global deforestation issue, international communities have been concentrating every effort. Reducing Emissions from Deforestation and Forest Degradation-puls (REDD+) is one of such efforts. For instance, the twenty-first session of the Conference of the Parties (COP 21) to UNFCCC embraced the Paris Agreement referring to promotion of REDD+, and many countries submitted Intended Nationally Determined Contributions (INDCs) which include the forest and land sector as one of key components for the emission reduction.

In accordance with the increase of the global concern about REDD+, both developing countries and international donors strengthen their efforts for REDD+, and the situations surrounding REDD+ are rapidly changing. It becomes significantly important for developing countries to understand the progress of readiness and implementation of REDD+ in their own countries to grasp the gap between its situation and requirements of international frameworks, and make effective strategies for REDD+.

#### For what?

For promoting REDD+ in participants' countries, this program aims to build the capacities of participants such as;

- To understand the effective strategy for promoting the implementation of REDD+ based on the situation of their countries, with considering the international frameworks and requirements of UNFCCC and REDD+ related funds.
- To formulate and implement REDD+ related policies based on their countries' situations.
- To gain REDD+ related funds to implement the national REDD+ strategy.

#### For whom?

Executive officers of national government who are engaged in policy making, institutional arrangement and implementation of REDD+

#### How?

Programs of this course are divided into 3 modules. Participants will learn how they can promote REDD+ implementation in their countries through various lectures, workshops and a site visit.

# [Module Output 1] Understanding the international frameworks, trends and requirements regarding REDD+

Through the variety of lectures, participants will learn international frameworks and trends such as UNFCCC including Paris Agreement. Participants will also study how to promote REDD+ implementation in an effective manner under the international frameworks.

The international frameworks require various conditions for preparation and implementation of REDD+. Among such requirements, this course will focus on Measurement, Reporting and Verification (MRV) and Safeguard (SG). Participants will learn the outline of MRV including National Forest Monitoring System (NFMS), Forest Inventory, Forest Reference Level (FREL), and study issues and measures that their countries face.

#### [Module Output 2] Understanding mechanisms of international funds

Since several international donors such as UNDP and WB formulate international funding mechanisms for boosting the implementation of REDD+, developing countries have opportunities to get funds for preparation and/or implementation of REDD+ if they understand and satisfy the requirements. In this course, participants will learn trends of international funds as well as Japanese Bi-lateral fund, and their requirements. Through these lectures, participants will understand how to utilize these funding mechanisms for REDD+ implementation in their countries.

# [ Module Output 3 ] Analyzing the current situation of participants' countries

By using the knowledge obtained through lectures and workshops, participants are required to analyze in detail about the current situation of REDD+ in their countries and formulate a short and mid-term REDD+ Action Plan (RAP) (for 5 years). RAP should include the current forest situation, issues and countermeasures for preparation and implementation of REDD+ of their countries.

Participants are also required to give a presentation of RAP in the end of this course.

In addition, to understand the sub-national policy and field level activities of forestry in Japan, participants will make a field trip to a national forest.

- To understand the effective strategy for promoting the implementation of REDD+ based on the situation of their countries, with considering the international frameworks and requirements of UNFCCC and REDD+ related funds.
- To formulate and implement REDD+ related policies based on their countries' situations.
- To gain REDD+ related funds to implement the national REDD+ strategy.

## III. Conditions and Procedures for Application

#### 1. Expectations from the Participating Organizations

- (1) This program is designed primarily for organizations that intend to address specific issues or problems identified in their operation. Participating organizations are expected to use the project for those specific purposes.
- (2) This program is enriched with contents and facilitation schemes specially developed in collaboration with relevant prominent organizations in Japan. These special features enable the project to meet specific requirements of applying organizations and effectively facilitate them toward solutions for the issues and problems.
- (3) As this program is designed to facilitate organizations to come up with concrete solutions for their issues, participating organizations are expected to make due preparation before dispatching their participants to Japan by carrying out the activities of the Preliminary Phase described in section II -9.
- (4) Participating organizations are also expected to make the best use of the results achieved by their participants in Japan by carrying out the activities of the Finalization Phase described in section II -9.

#### 2. Nominee Qualifications

Applying Organizations are expected to select nominees who meet the following qualifications.

#### (1) Essential Qualifications: Applicants should

- 1. To achieve the output previously described, especially the criteria following is important: be a central government official who are currently playing a major role in REDD+ policy making and implementation.
- 2. be nominated by their government in accordance with the procedures mentioned in 4. "Procedure for Application and Selection" below,
- 3. Preferably over 35 years and under 59 years of age.
- 4. have sufficient command of English,
  - (During the course program, participants are requested to give presentations and actively participate in discussions. Communication and presentation Skills in English are essentially important.)
- 5. be in good health, both physically and mentally, to participate in the Program in Japan. Pregnant applicants are not recommended to apply due to the potential risk of health and life issues of mother and fetus.
- 6. be proficient in MS Word, Excel and Power Point.

#### 3. Required Documents for Application

to be submitted with the application form. If you have any official documentation of English ability (e.g. TOEFL, TOEIC, IELTS).

#### 4. Procedures for Application and Selection

#### (1) Submission of the Application Documents

Closing date for applications: Please inquire to the JICA office (or the Embassy of Japan).

(After receiving applications, the JICA office (or the Embassy of Japan) will send them to the JICA Center in Japan by Friday, 24<sup>th</sup> March 2017.)

#### (2) Selection

After receiving the documents through proper channels from your government, the JICA office (or the Embassy of Japan) will conduct screenings, and then forward the documents to the JICA Center in Japan. Selection will be made by the JICA Center in consultation with concerned organizations in Japan. The applying organization with best intention to utilize the opportunity of this program will be highly valued in the selection. Qualifications of applicants who belong to the military or other military-related organizations and/or who are enlisted in the military will be examined by the Government of Japan on a case-by-case basis, consistent with the Development Cooperation Charter of Japan, taking into consideration their duties, positions in the organization, and other relevant information in a comprehensive manner.

#### (1) Notice of Acceptance

Notification of results will be made by the JICA office (or the Embassy of Japan) **not** later than Monday, <u>24<sup>th</sup> April 2017.</u>

#### 5. Conditions for Attendance:

- (1) to strictly adhere to the program schedule.
- (2) not to change the program topics.
- (3) not to extend the period of stay in Japan.
- (4) not to be accompanied by family members during the program.
- (5) to return to home countries at the end of the program in accordance with the travel schedule designated by JICA.
- (6) to refrain from engaging in any political activities, or any form of employment for profit or gain.
- (7) to observe Japanese laws and ordinances. If there is any violation of said laws and ordinances, participants may be required to return part or all of the training expenditure depending on the severity of said violation.
- (8) to observe the rules and regulations of the accommodation and not to change the accommodation designated by JICA.

#### **Country Report Presentation**

At the beginning of the core phase in Japan, each participant is requested to make an approximately **10-15minites** presentation based on the Country Report. Purpose of the presentation is sharing each country's situation of forest and NFMS/NFI among participants, implementing partner (underplanning) and JICA, which is one of the important elements of this course. Therefore, presentation should be well

prepared in advance and effectively conducted to share the essential information.

#### Presentation style - Microsoft PowerPoint recommended

It is recommended to use PowerPoint (if possible) to present your Country Report. Upon formulating the presentation material, please make slides simple, limiting text as much as possible and utilize graphics (photos, maps, tables or charts) instead. Too much information (especially text) in one slide might give weaker impression to the audience, and interrupt better understanding of the presentation.

#### For Your Reference

#### **JICA and Capacity Development**

The key concept underpinning JICA operations since its establishment in 1974 has been the conviction that "capacity development" is central to the socioeconomic development of any country, regardless of the specific operational scheme one may be undertaking, i.e. expert assignments, development projects, development study projects, training programs, JOCV programs, etc.

Within this wide range of programs, Training Programs have long occupied an important place in JICA operations. Conducted in Japan, they provide partner countries with opportunities to acquire practical knowledge accumulated in Japanese society. Participants dispatched by partner countries might find useful knowledge and re-create their own knowledge for enhancement of their own capacity or that of the organization and society to which they belong.

About 460 pre-organized programs cover a wide range of professional fields, ranging from education, health, infrastructure, energy, trade and finance, to agriculture, rural development, gender mainstreaming, and environmental protection. A variety of programs and are being customized to address the specific needs of different target organizations, such as policy-making organizations, service provision organizations, as well as research and academic institutions. Some programs are organized to target a certain group of countries with similar developmental challenges.

#### **Japanese Development Experience**

Japan was the first non-Western country to successfully modernize its society and industrialize its economy. At the core of this process, which started more than 140 years ago, was the "adopt and adapt" concept by which a wide range of appropriate skills and knowledge have been imported from developed countries; these skills and knowledge have been adapted and/or improved using local skills, knowledge and initiatives. They finally became internalized in Japanese society to suit its local needs and conditions.

From engineering technology to production management methods, most of the know-how that has enabled Japan to become what it is today has emanated from this "adoption and adaptation" process, which, of course, has been accompanied by countless failures and errors behind the success stories. We presume that such experiences, both successful and unsuccessful, will be useful to our partners who are trying to address the challenges currently faced by developing countries.

However, it is rather challenging to share with our partners this whole body of Japan's developmental experience. This difficulty has to do, in part, with the challenge of explaining a body of "tacit knowledge," a type of knowledge that cannot fully be expressed in words or numbers. Adding to this difficulty are the social and cultural systems of Japan that vastly differ from those of other Western industrialized countries, and hence still remain unfamiliar to many partner countries. Simply stated, coming to Japan might be one way of overcoming such a cultural gap.

JICA, therefore, would like to invite as many leaders of partner countries as possible to come and visit us, to mingle with the Japanese people, and witness the advantages as well as the disadvantages of Japanese systems, so that integration of their findings might help them reach their developmental objectives.
