This information pertains to one of the JICA Knowledge Co-Creation Program (Group & Region Focus) of the Japan International Cooperation Agency (JICA), which shall be implemented as part of the Official Development Assistance of the Government of Japan based on bilateral agreement between both Governments.

'JICA Knowledge Co-Creation (KCC) Program' as a New Start

In the Development Cooperation Charter which is released from the Japanese Cabinet on February 2015, it is clearly pointed out that "In its development cooperation, Japan has maintained the spirit of jointly creating things that suit partner countries while respecting ownership, intentions and intrinsic characteristics of the country concerned based on a field-oriented approach through dialogue and collaboration. It has also maintained the approach of building reciprocal relationships with developing countries in which both sides learn from each other and grow and develop together." We believe that this 'Knowledge Co-Creation Program' will serve as a center of mutual learning process.

I. Concept

Background

TV broadcasting is one of the most efficient and inexpensive methods of communication, which can convey information equally to all across the world. TV broadcasting enables to promote efficient knowledge dissemination and public awareness in the field of education, health service, environment, peace—building, and consolidation of democracy. Its potency is very much expected as a means of transmitting information where other information media are inefficient or unavailable, such as isolated areas.

The digitalization of TV broadcasting has become a global trend, and many developed and developing countries have already started digital broadcasting. Developing countries with diversified cultures (languages, ethnicities) can take advantage of the features of digital broadcasting: Attractive and convenient services available with digital broadcasting, such as multilingual broadcasting, text broadcasting, multi-channel services etc. can contribute to the improvement of citizens' quality of life and level of education. Prompt provision of disaster information through data broadcasting and mobile broadcasting can mitigate the impact of natural disasters on their inhabitants.

For what?

This program aims to provide hints and solutions for effective digitalization of TV broadcasting; Learning not only digital broadcasting technology and theory, but also actions and solutions applied to successfully complete switchover from analog to digital TV broadcasting in Japan: these lessons will serve as guidelines for digitalization of TV broadcast of each country.

For whom?

This program is offered to broadcasting organizations and its related governmental organizations of those countries which have adopted or are considering ISDB-T as their digital terrestrial TV broadcasting system.

To understand the advantages of digital broadcasting system, promoting the systematical and logical digitalization process of the broadcasting in participants' organizations.

To contribute to the spread of education and efficient information sharing, which is essential to the improvement of living standards, by introducing a variety of multifunctional services provided stably through digital broadcasting.

III. Conditions and Procedures for Application

1. Expectations from the Participating Organizations:

- (1) This program is designed primarily for organizations that intend to address specific issues or problems identified in their operation. Participating organizations are expected to use the project for those specific purposes.
- (2) This program is enriched with contents and facilitation schemes specially developed in collaboration with relevant prominent organizations in Japan. These special features enable the project to meet specific requirements of applying organizations and effectively facilitate them toward solutions for the issues and problems.

2. Nominee Qualifications:

Applying Organizations are expected to select nominees who meet the following qualifications.

(1) Present position, assignment:

Officials who is in charge of the planning of the Digital Terrestrial TV Broadcasting, (Acting) Team Leader of TV broadcasting organization or Government-related organization in charge of Digital Terrestrial TV Broadcasting policy, or Engineers who have practical experience in TV transmission.

(2) Occupational background:

Have technical background

Be in charge of planning /implementation of digitalization of the broadcast.

Note: Studio engineer and those who have experience only in Radio
Stations are **NOT** qualified.

(3) Academic record:

College or university graduates, or those who have the equivalent in technical knowledge of electronic engineering and fundamental knowledge about digital engineering theory.

(4) Computer skill:

Have basic skills of PC operation using Word, Excel, and other software.

(5) Age:

Under forty (40) years of age, in principle

(6) Language:

Proficiency in spoken and written English

(7) Health:

Health: must be in good health, both physically and mentally, to participate in the Program in Japan. Pregnant applicants are not recommended to apply due to the potential risk of health and life issues of mother and fetus.

3. Required Documents for Application

- (1) Application Form: The Application Form is available at the JICA office (or the Embassy of Japan).
- (2) Photocopy of passport: to be submitted with the application form, if you possess your passport which you will carry when entering Japan for this program. If not, you are requested to submit its photocopy as soon as you obtain it.

*Photocopy should include the followings:

Name, Date of birth, Nationality, Sex, Passport number and Expire date.

- (3) Nominee's English Score Sheet: to be submitted with the application form. If you have any official documentation of English ability. (e.g., TOEFL, TOEIC, IELTS)
- (4) JOB Report (Annex 1): submitted with the application form. Fill in Attachment-1 of this General Information.

4. Procedures for Application and Selection:

(1) Submission of the Application Documents:

Closing date for applications to the JICA Center in JAPAN: <u>May 2, 2017</u> (After receiving applications, the JICA office (or the Embassy of Japan) will send them to the JICA Center in JAPAN by May 2, 2017)

(2) Selection:

After receiving the documents through proper channels from your government, the JICA office (or the embassy of Japan) will conduct screenings, and then forward the documents to the JICA Center in Japan. Selection will be made by the JICA Center in consultation with concerned organizations in Japan. The applying organization with the best intention to utilize the opportunity of this program will be highly valued in the selection. Qualifications of applicants who belong to the military or other military-related organizations and/or who are enlisted in the military will be examined by the Government of Japan on a case-by-case basis, consistent with the Development Cooperation Charter of Japan, taking into consideration their duties, positions in the organization, and other relevant information in a comprehensive manner.

(3) Notice of Acceptance

Notification of results will be made by the JICA office (or the Embassy of Japan) not later than <u>May 12</u>, 2017.

5. Document(s) to be submitted by accepted candidates:

Inception Report -- to be submitted <u>by June 9, 2017:</u>
Before coming to Japan, only accepted candidates are required to prepare an **Inception Report (Annex 2)**. The Inception Report should be sent to JICA by

June 10, 2017, preferably by e-mail to tictee@jica.go.jp

6. Conditions for Attendance:

- (1) to strictly adhere to the program schedule.
- (2) not to change the program topics.
- (3) not to extend the period of stay in Japan.
- (4) not to be accompanied by family members during the program.
- (5) to return to home countries at the end of the program in accordance with the travel schedule designated by JICA.
- (6) to refrain from engaging in any political activities, or any form of employment for profit or gain.
- (7) to observe Japanese laws and ordinances. If there is any violation of said laws and ordinances, participants may be required to return part or all of the training expenditure depending on the severity of said violation.
- (8) to observe the rules and regulations of the accommodation and not to change the accommodation designated by JICA.
