# **Singapore Cooperation Programme**

Singapore has provided technical assistance to other developing countries since the 1960s. As a country whose only resource is its people, Singapore believes that human resource development is vital for economic and social progress. Singapore itself has benefited from training provided by other countries and international organisations.

In 1992, the Singapore Cooperation Programme (SCP) was established to bring together under one framework the various technical assistance programmes offered by Singapore. Through the SCP, the range and number of training programmes were increased to share Singapore's development experience with other developing countries.

To date, Singapore has sponsored training courses and study visits for over 120,000 officials from more than 170 countries. The SCP is managed by the Technical Cooperation Directorate of the Singapore Ministry of Foreign Affairs.

## Singapore Judicial College

Established under the auspices of the Supreme Court of Singapore, the Singapore Judicial College (SJC) is dedicated to the learning and developmental needs of a professional judges corps. The SJC's Local Wing conducts continuing education and specialised training programmes for the Singapore Bench, whereas its International Wing offers customised programmes, as well as lends technical assistance, to foreign jurisdictions. The SJC's Empirical Judicial Research initiative provides a unique opportunity for research projects based on quantitative and data analysis to be undertaken to produce innovative judicial policies and practices.





## **Course Objectives**

At the end of the course, participants will gain an appreciation of the:

- Rights and duties under the institution of marriage;
- Proper dissolution of marriages and management of ancillary matters such as custody and access, division of matrimonial properties and maintenance:
- Protection of and offences against women and girls in Singapore;
- · Role of civil society organisations;
- Day-to-day work of relevant government agencies and organisations in Singapore.

### **Synopsis**

This programme provides an overview of the protection, rights and obligations afforded under the Women's Charter in Singapore, specifically in relation to the institution of marriage and offences against women and girls. It also introduces the role of civil society organisations and the United Nations Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW). There will also be site visits to the Family Justice Courts, Ministry of Social and Family Development, and the Singapore Council of Women's Organisations.

### Methodology

- Formal lectures;
- Case studies and analyses;
- Group discussions and presentations;
- Constructive peer-review and critique;
- Sharing and reflections

#### Duration

The course will be held from 3 to 7 September 2018.

## **Application Information**

Applicants should be:

- Judges, judicial officers, government social workers and officers involved in the dispensation and administration of family justice and protection;
- · Nominated by their respective Governments;
- · Proficient in written and spoken English;
- · In good health

### **Terms of Award**

The course is sponsored by the Government of Singapore under the Singapore Cooperation Programme Training Award.

Under this programme arrangement, the Government of Singapore will bear the following expenses for the successful applicants (thereafter known as participants) during their training in Singapore. These expenses include:

- A daily training allowance of One Hundred and Twenty Singapore Dollars (S\$120) from first day to last day of the course to cover meals and daily expenses; [Complimentary breakfast is provided in the hotel from the first day to one day after the course.]
- Transportation to course venue and site visits;
- Medical insurance for participants to cover accident and hospitalisation during their stay in Singapore in accordance with the policy of a local insurance company;
- Accommodation for the entire duration of the course.

#### Note:

- The nominating government will be responsible for its participants' round-trip airfares;
- (ii) Participants are to bear their personal miscellaneous expenses that might be incurred prior to receiving the allowance:
- (iii) Any expenses for out-patient medical/dental treatment will be borne by the participants themselves

#### Regulations

Participants are required to comply with the following:

- (a) Strictly observe course schedules and not miss training sessions;
- (b) Not bring any member of their family and/or aide for the duration of the course;
- (c) Carry out instructions and abide by conditions as may be stipulated by the nominating Authority or the Government of Singapore with respect to the course;
- (d) Refrain from engaging in political activities, or any form of employment for profit or gain while in Singapore;

- (e) Discontinue the course, in the event they fall seriously ill and are considered unable to continue the training or have committed an improper act;
- (f) Return to their respective home countries upon completion of the course

## **Application Procedure**

(Closing date for nomination: 23 July 2018)

The Government of Singapore is pleased to invite the respective National Focal Point for Technical Assistance to nominate <u>one (1)</u> suitable applicant. Selection of candidates will be based on merit. Should there be more applicants than training places, the Government of Singapore seeks the understanding of the respective National Focal Point for Technical Assistance in the event that its nominee(s) is not selected.

Information submitted online must be endorsed by the National Focal Point by <a href="Monday, 23 July 2018">Monday, 23 July 2018</a>.

- The Ministry of Foreign Affairs, Singapore will inform all applicants of the outcome of their applications. The National Focal Point for Technical Assistance will also be informed directly or through Singapore's diplomatic representations in the nominating country;
