

ABOUT MTCP

The Malaysian Technical Cooperation Programme (MTCP) was first initiated at the First Commonwealth Heads of Government Regional Meeting (CHOGRM) for Asia Pacific Region in Sydney in February 1978. It was officially launched on 7 September 1980 at the 2nd CHOGRM in New Delhi, India, to signify Malaysia's commitment to South-South Cooperation, in particular Technical Cooperation among Developing Countries (TCD). In line with the spirit of South-South Cooperation, Malaysia through the MTCP shares its development experiences and expertise with other developing countries. The MTCP was first formulated based on the belief that the development of a country depends on the quality of its human resources. The programme forms part of the commitment of the Malaysian Government towards the promotion of technical cooperation among developing countries, strengthening of regional and sub-regional cooperation, as well as nurturing collective self-reliance among developing countries. The MTCP emphasises the development of human resources through the provision of training in various areas which are essential for a country's development such as public administration, good governance, health services, education, sustainable development, agriculture, poverty alleviation, investment promotion, ICT and banking. Since its inception in 1980, more than 33,000 participants from 144 recipient countries have benefited from the various programmes offered under the MTCP. Applications should be made using the prescribed MTCP forms available at

se. MTCP application forms can also be obtained at nearest Malaysian Embassies in recipient countries.

All application forms must be duly completed and endorsed by the Ministry of Foreign Affairs or National Focal/Aid Coordinator Agency in the respective countries (the relevant ministry or agency responsible for the overall coordination of international technical assistance) and should be submitted ONLY through the diplomatic channel via Embassy of Malaysia in the respective countries. Submitted application forms must be accompanied by the applicant's:

- * Copy of Passport
- * Passport sized coloured photo (3.5cm x 5cm)
- * Medical Report

Only successful applicants will be notified.

Objectives:

- appreciate Malaysia's experience in achieving her vision
- benchmark the Royal Malaysian Customs' experience in collection of revenue, promotion of trade/industrialization, enforcement of relevant legislations and secure the supply chain security
- discover the WCO CLIKC modules as a component to effective training
- identify the various types of dangerous drugs and precursor chemicals
- handle exhibits in cases involving drugs more effectively
- identify methods of concealment of drugs and modus operandi commonly used in drug smuggling activities
- enforce relevant laws related to dangerous drugs
- share experiences with other customs administrations on the subject matter

Course Contents:

- WCO CLIKC modules related to customs control
 - group dynamics
 - Malaysia: History, Culture, Economy, Social and Political
 - MTCIP: Malaysian experience in developing human capital
 - introduction to the Revised Kyoto Convention (RKC) & Advance Passenger Information System (APIS): simplification and harmonization of customs procedures, facilitation & effective control, as well as, related supply chain security
 - overview of narcotic substances trafficking and international cooperation at the WCO level
 - identification of the various types of dangerous drugs & drug testing methods
 - precursor awareness and chemical control
 - investigation techniques in cases involving dangerous drugs & handling exhibits
 - enforcement of Dangerous Drug Laws at various modes – sea, air & land.
 - offences under the Dangerous Drugs legislation, including the ingredients of the various offences
 - comparative study tour: sharing of good practices presentation of Country and Attachment/Comparative reports
- Course Methodology:**
- This is an interactive course that will provide participants with the opportunity to freely exchange of ideas, knowledge and experiences with the other fellow participants and facilitators/resource persons. These will be achieved through lectures, individual presentation, group discussion, questions & answers session and field visits.
 - The use of the WCO CLIKC modules as supplement
 - The course will be conducted in English (English proficiency, both oral and written, is required and our nearest Mission may interview the applicant to verify the claimed proficiency).

Target Group, Qualification & Application Procedures:

- ✓ The preferred international candidates (sponsored under the MTCIP):
 - Senior or Mid-level Management Customs Officers who are heading an office or a station or a division or Customs Trainers from listed in the Malaysian Technical Cooperation Program (MTCIP) recipients list, age between 26 - 50 years and had never participated in any MTCIP programme;
 - certified medically fit, proficient in English and possess, preferably a tertiary education, with at least 5 years of working experience in customs matters relevant to the course
 - the application must be made using the specified MTCIP application form, completely filled and endorsed by the National Contact Point (if specified or the Office of the Ministry of Foreign / External Affairs) and submit via the Office of Foreign / International Affairs (National Focal Point) of the country with a copy directly send to AKMAL concurrently via fax or e-mail; and
- ✓ Senior officers of the Royal Malaysian Customs (Grades 41, 44 and 48) who are heading an office, a station or a section and his/her core business is related to the subject matter are also encourage to apply (Sponsored under the RMC's training budget)
- **Country Paper (written and oral presentation):**
 - Guidelines: Each selected / invited participant has to prepare a case study on the subject matter related to the course, from own country's experience. It should not be regarded as an evaluation of the practice by the participating administration; it should stress on the sharing of information and good practices.
 - Objective: To provide an opportunity for participants to exchange and share knowledge and experience related to the course contents.
 - Subject Area: The subject area should reflect the experience, prospects and challenges encountered in the planning and the implementation of the policies related to the subject matter from the individual participating administration.
- **Length of Report:**
 - 1 page on country/administration general information and background
 - 5 – 8 pages exploring the subject matter from the country's perspective including the good practices, prospects and challenges
 - 1 page of conclusion on expectation and future plan of action (POA) upon completion of the course.
- **Special Instructions:**
 - Selected participants must submit the completed Country Paper to the Course Coordinator at least 2 weeks before the course; it is a pre-requisite to the issuance of the air-tickets
 - The Paper should be typed-written, font 12-Arial in a Windows compatible programme and send by e-mail or fax
 - The participant will be required to make a 15-minutes in-class presentation based on the submitted paper using PowerPoint and be prepared for Q & A and discussion right after the presentation.

OTHER INFORMATIONS

- 1. Air Fare**
The Government of Malaysia shall provide excursion economy air ticket to all MTCIP participants from the capital city of the MTCIP recipient country to Kuala Lumpur and return air ticket from Kuala Lumpur to the capital city of the MTCIP recipient country.
- 2. Accommodation**
• Participants will be accommodated either in the hostel located in the vicinity of the Training Institutions or at the nearby hotels. Participants are strictly not allowed to bring any family members during the course.
- 3. Course Fee and Registration**
All course fees will be borne by the Malaysian Government under the MTCIP.
- 4. Medical and Dental Treatment**
Medical treatments are provided at government hospitals/clinics only and the expenses will be borne by the Government of Malaysia under the MTCIP. In case of an emergency, participants are eligible to be admitted to government hospitals/clinics. Dental treatments are restricted to extraction and filling only.
- 5. Visa-With-Reference**
Visa and Vaccination It is mandatory for all the MTCIP participants to follow the Visa With Reference (VDR) application procedure. Once the approval is obtained, the training institution should send a copy of VDR approval letter to the participants. Subsequently, with the copy of the approval, the participants may get the VDR from the nearest Embassy of Malaysia. Wherever applicable, participants are advised to arrange for vaccination on their own prior to travel to Malaysia.
- 6. Vaccination for Yellow Fever**
Expenditures on all visa-related fees, airport tax/airport user's charge, transit insurance, excess luggage, travel tax, transit fees, domestic passenger terminal fees, phone charges, private purchases, etc borne by the participants.
- 7. Mandatory Vaccination for yellow fever at least 10 days prior to their departure to Malaysia.**
Yellow Fever certificate is required to be produced upon landing in Malaysia for countries as listed at the link below:

- 8. Manners**
Participants shall conduct themselves at all times in a manner compatible with their responsibilities as MTCIP participants and abide by the laws, rules and regulations as may be stipulated by the host government in respect of this training course.
