MALAYSIAN TECHNICAL COOPERATION PROGRAMME (MTCP)

The Malaysian Technical Cooperation Programme (MTCP) was officially launched on 7 September 1980 at the Commonwealth Heads of State Meeting in New Delhi, India, to signify Malaysia's commitment to the South-South Cooperation, in particular, the Technical Cooperation among Developing Countries (TCDC).

The MTCP emphasizes on the development of human resources through the provision of trainings in various areas which are essential for a country's development such as the public administration, good governance, health services, education, agriculture, sustainable development, poverty alleviation, investment promotion, ICT and banking. Annually, Malaysia offered more than 65 technical and capacity-building programmes under the MTCP, which have benefited more than 34,000 participants from 144 countries.

NATIONAL INSTITUTE OF LAND AND SURVEY (INSTUN)

The National Institute of Land and Survey (INSTUN) is a training institute under the Ministry of Energy and Natural Resources, Malaysia. INSTUN is oficially established on the 1st of May 1998 through a combination of Training Section, Department of Director General of Land and Mines (JKPTG) and Training Section, Department of Survey and Mapping Malaysia (JUPEM).

INSTUN is located 136 km from KLIA and 90.6 km from Kuala Lumpur city centre. INSTUN initially operated on its own building in 2002 which is located at Behrang Ulu, Tanjung Malim, Perak. A new administration building has fully been established in 2011 and started operation in early 2012. This new building comprises with a Director Office, Administration and Financial Division Office. As a Public Training Institute (ILA) in Malaysia, INSTUN provides training in the field of land surveying, mapping and related information technology, while also providing references materials and information related. INSTUN is also the only Public Training Institute in Malaysia which offered in these training related fields.

In general, there are four main functions of INSTUN which are conducting training in land administration, surveying and mapping, and information technology as well as conducting a research studies in these fields. INSTUN also act as a reference agency in the field of land administration, surveying and mapping and information technology.

EVOLUTION OF LAND ADMINISTRATION AND DEVELOPMENT POLICY IN MALAYSIA ABOUT THE COURSE

Generaly there are various land management and legislation system being practiced throughout the world. Each and every system has its own characteristics, distinctive features and uniqueness. A study of the development of Malaysian land management system (includes land law) can be traced long before the period of independence (pre1957). Malaysian land tenure and land law has adopted and incorporated the Torrens System which originally came from Southern Australia. This system had been gradually modified to suit local needs until today. This process was done by the introduction of the National Land Code 1965 as the only code governing all matters and legal requirements for land tenure and land law in all states of Peninsular Malaysia.

Besides that, the introduction of several Electronic-Systems for the usage of land administration throughout Peninsular Malaysia such as Computerized Land Registration System, E-Tanah System and My-eTAPP System is a crucial and big step being taken by the Government to enhance all matters relating to the administration of land. Economic development is one of the common goals of many developing countries. The nature of development policy adopted by the government pertaining to Land Administration affect the level of economic performance a country. The fundamental issues of land acquisition, distribution and management of land are determined by land policy. Land administration and associated systems are the mechanisms that drive the country towards achieving such policies goals and objective.

In the World Bank's Ease of Doing Business Report 2019 Malaysia has jumped from 24th place to 15th place globally. This jumped has been made possible with the help of the effectiveness of Malaysia's Land Administration System which is part of the criteria evaluated. As land administration and legislation gradually evolve, it has played important roles in the development of Malaysia in order to achieve the developed country status. Its contributions can be traced to some successful programs and projects initiated by the Government for the betterment of the life of Malaysian.

- To expose and create fundamental and basics understanding of Malaysian land administration and legislation;
- To share Land Administration roles and importance in Developmental Policy
- To share Malaysia's land administration roles and contributions in the development process to achieve developed country status; and
- To share experience in managing land issues and problems.
