Malaysian Technical Coorperation Programme (MTCP)

The Malaysian Technical Cooperation Programme (MTCP) was officially launched on 7 September 1980 at the Commonwealth Heads of State Meeting in New Delhi, India, to signify Malaysia's commitment to the South-South Cooperation, in particular, the Technical Cooperation among Developing Countries (TCDC).

The MTCP emphasizes on the development of human resources through the provision of trainings in various areas which are essential for a country's development such as the public administration, good governance, health services, education, agriculture, sustainable development, poverty alleviation, investment promotion, ICT and banking. Annually, Malaysia offered more than 65 technical and capacity-building programmes under the MTCP, which have benefited more than 34,000 participants from 144 countries.

Objectives

- To share the development experience with other countries;
- To strengthen bilateral relations between Malaysia and other developing countries;
- To promote South-South Cooperation (SSC); and
- ▶ To promote the technical cooperation among Developing Countries

Malaysia Anti-Corruption Academy (MACA)

MACA, established on 1st December 2005, being a training academy in itself, is responsible for managing specialized training programmes to enhance competency and professionalism to both local and and international participants. MACA is also responsible for providing training programmes in various fields, such as investigation, prosecution, intelligence, prevention, consultancy and management. These programmes are of high quality and equips the participants with the needed knowledge and skills in combating corruption. The division comprises of several centres and schools, which manage their respective fields of study.
