ABOUT MTCP

The Malaysian Technical Cooperation Programme (MTCP) was officially launched on 7 September 1980 at the Commonwealth Heads of State Meeting in New Delhi, India, to signify Malaysia's commitment to the South-South Cooperation, in particular, the Technical Cooperation among Developing Countries (TCDC).

The MTCP emphasizes on the development of human resources through the provision of training in various areas which are essential for a country's development such as agriculture, economy, finance, public management and administration, science & technology and ICT, health diplomacy, safety and security including cyber security, cultural diplomacy, social development, environment-related to SDG2030, education, industrial and technical training. Annually, Malaysia offered more than 60 technical and capacity-building programs under the MTCP, which have benefited more than 35,500 participants from 144 countries.

The 2022 MTCP International Training Course on The Future: Malaysia's Insights on the Policy, Economy & Investment in Maritime Industry will give participants an overview on how Malaysia's authorities develop the policies that affects two Malaysia's ports namely Tanjung Pelepas Port and Klang Port to be in the top 15 best ports in the world where both had a very humble beginning. After completing this course, participants should understand how Malaysia's policymakers developed their policy to make Malaysia's largest ports competitive on an international level.

COURSE CONTENT

The 4-day course includes an Overview of Maritime Policy and Investment through Government Agencies Scheme, the humble start of Port Klang (PKA) and Port of Tanjung Pelepas (PTP), and How Maritime Can Win Cross-border Businesses? Participant will make country presentation at the end of the course.

COURSE OBJECTIVES

The major objectives of this training course are as follows:

- Enhance understanding of the developed policies and action taken especially on economic movement and investment done by Malaysian government.
- Understand the growing complexity of the maritime industry especially port handling.
- Share best practices of the respective countries in the maritime industry operation and management through policies.

COURSE METHODOLOGY

The course will include a combination of the following:

- Lectures
- Case studies
- Group presentations

ELIGIBILITY

This training course is designed for senior and middle level officials or industrial practitioners from maritime industry or related agency responsible in the relevant ministries, departments, and organisations specifically involved in the maritime industry operation and management. Participants should be nominated by the respective governments based on the following:

- Senior and middle level officials or managers from maritime industry or related agency
- Possess a good command of both written and spoken English
- Aged preferably 26-50 years

MEDIUM OF INTERACTION

The training course will be fully conducted in English.

COURSE DURATION

The training course will be from 12 to 15 July 2022 via cloud-based video communications app.

COURSE FEE AND REGISTRATION

All course fees will be borne by the Malaysian Government under the MTCP.

MTCP application forms can also be obtained from the nearest Malaysian Embassy/High Commission in recipient countries. All application forms must be duly completed and endorsed by the Ministry of Foreign Affairs or National Focal/Aid Coordinator Agency in the respective countries and submitted ONLY through the diplomatic channel via the Embassy/High Commission of Malaysia.

Only successful applicants will receive the Official Invitation notification one (1) week from the course date, by the Training Institute via email.

MANNERS

Participants shall conduct themselves at all times in a manner compatible with their responsibilities as MTCP participants and abide by the laws, rules and regulations, as may be stipulated by the host government in respect of this training course.

DRESS CODE

During lectures, male participants are required to dress in long-sleeved shirts with ties whereas female participants should be appropriately dressed in office attire.
