## Malaysian Technical Cooperation Programme (MTCP)

The Malaysian Technical Cooperation Programme (MTCP) was officially launched on 7 September 1980 at the Commonwealth Heads of State Meeting in New Delhi, India, to signify Malaysia's commitment to the South-South Cooperation, in particular, the Technical Cooperation among Developing Countries (TCDC).

The MTCP emphasizes on the development of human resources through the provision of training in various areas which are essential for a country's development such as agriculture, economy, finance, public management and administration, science & technology and ICT, health diplomacy, safety and security including cyber security, cultural diplomacy, social development, environment-related to SDG2030, education, industrial and technical training. Annually, Malaysia offered more than 60 technical and capacity-building programs under the MTCP, which have benefited more than 35,500 participants from 144 countries.

### Objectives

- To share the development experience with other countries;
- To strengthen bilateral relations between Malaysia and other developing countries;
- To promote South-South Cooperation (SSC); and
- To promote technical cooperation among Developing Countries.

## Malaysia Anti-Corruption Academy (MACA)

MACA, a training academy established on 1st December 2005, is responsible for managing specialized training programmes to enhance the competency and professionalism of both local and international participants. MACA is also responsible for providing training programmes in various fields such as investigation, prosecution, intelligence, prevention, consultancy and management. These programmes are of high quality and equip the participants with the needed knowledge and skills in combating corruption. The division comprises several centres and schools, which manage the respective fields of studies.

Due to the Covid-19 outbreak, the previous face-to-face method will be transformed according to the new norm which is Online training. With the ongoing situation around the world, MACA has decided that Online learning is the best method to conduct its training for convenience in terms of access and constraints of movement into and out of the country that can make the objectives of knowledge sharing realized.
